How to contact us



Police Assistance Line (131 444) For non emergencies.



Crime Stoppers (1800 333 000)

To provide crime information. It can be anonymous.

For emergencies or life-threatening situations:

Call triple zero **000 immediately** and have your exact location details ready.

When it is not an emergency:

Call the Police Assistance Line on 131 444. Or use the online community portal. This is to report minor crimes like stolen property, damaged vehicles or lost property e.g. if you lose your passport, phone etc.

If you see something suspicious:

Call Crime Stoppers on 1800 333 000. This is to report issues such as suspected illicit drug dealing or possible terrorist related activity etc. The triple zero **000** operator will ask who you need: **Police**, **Fire**, **Ambulance**.

Emergency Plus App

In Emergency Plus is an app that can be downloaded for free to smartphones, Android and iOS devices.

The app can help you to choose the right emergency number to call for help in emergency and non-emergency situations.

The app identifies your location via GPS tracking.

If you are unsure of your exact location, tell the operator the three words listed on the screen and the operator will be notified of your location.

Plain Clothes Police

If a police officer is in plain clothes and they want to arrest, search or ask an individual to 'move-on', the officer must tell the person that they are a police officer and state their name, rank and station and show them their ID.

You can always ask a Police Officer to provide their identification.



Virtual Kidnapping

- NSW Police is urging the community to be on alert following a rise in suspicious phone calls, also known as 'virtual kidnapping' scams, targeting Chinese international students

SCAM ALERT!

VIRTUAL KIDNAPPINGS:

Scammers impersonate Chinese government authorities or military officials and extort the victim. They tell the victim they have been implicated in a crime and need to pay money to avoid deportation. As the scam escalates, through coercion, they get victims to stage their **@Wh** fake kidnapping. The families involved are led to believe the victim is in danger and a ransom needs to be paid to secure their release.

HOW TO REPORT:

DO NOT reveal any PERSONAL information

- . In an EMERGENCY call 000.
- 2. Call the Police Assistance Line (PAL) 131 444 (for all non-emergency reporting).
- BO NOT send any money and HANG up the call immediately. DO collect as much information/ data about the scammer as possible
 - DO report any suspicious scam/ behaviour to Police & ScamWatch
 - **DO** speak to friends/family about the incident for support.

DO contact the Chinese Consulate for advice and to report.

Sextortion

- Never send intimate photos/videos to people you meet online.
- Never share your personal information or bank details even if they offer to give you money.
- Do not pay or comply with extortion demands. They may ask for more money or release your photos/ videos anyway.
- Take screenshots of the communication text and profile.

After gathering evidence, report the account to the platform and block it.

SEXTORTION

Sexual extortion (or sextortion) is a form of blackmail where someone threatens to share intimate personal images of you online unless their demands are met. These demands are typically for money, more intimate images or sexual favours.

NSW Police Force takes sexual extortion seriously and there are consequences.

In NSW the recording or capture, distribution, as well as the threat to record or distribute, an intimate image is against the law.

If you experience image-based abuse police can investigate.

- Do not pay or send any more images or videos of yourself.
- Stop all contact with the blackmailer
- Notify the relevant social media platform
- Secure your accounts.

Remember, it is not your fault, you are not alone and you have not done anything wrong.


Phone call advising there is a...



Australian government departments won't

ask you for payment using gift cards either!

- Scammers will often call people and claim to be police officers, a member of the Australian Tax Office or other government officials.
- Scammers typically ask for money to be sent via wire transfer or will ask you to buy iTunes cards to pay an outstanding debt.
- Be on guard, if you receive a phone call from someone saying you have an arrest warrant and asking you to pay a fee, hang up and do not respond. If in doubt, don't use the contact details provided - look up the government department or organisation yourself in the phone book or online and phone or email them.




Remember:

Mail & Identity Theft



Is your mailbox secure?

Locking your letterbox with a nonmaster key lock is a great way of securing your mail from theft.

How often do you clear your mailbox?

Do it daily. Overflowing mailboxes are a criminals paradise.

Are you getting a new credit card?

Arrange to collect it in person.

Are you going on holiday?

Have a friend or relative clear your mail daily. Australia Post also offers a Mail Hold service for a reasonable fee. They'll hold your mail at the post office until you return from your trip. Find out more at auspost.com.au or call 13 POST (13 76 78).



Sexual Assault

- It's important to check for consent, every time.
- Sexual assault is a serious crime that can impact anybody.
- NSW Police Force understands that reporting sexual assault can be distressing and traumatic, especially for international students.
- Experienced investigators will explain all the available options to the student, then take their statement if they wish to formally report the matter.
- The police can also organise extra support including medical care and counselling for victims, using a range of government and non-government agencies.

Persons under the age of 18 years are not permitted in this area by law.

Photo ID

 Must be presented when purchasing alcohol or trying to enter a licensed premises.

Applying for a NSW Photo Card

 NSW Photo Cards may be used as photo identification if students don't have a NSW Driver Licence.

You will be refused entry or asked to leave this venue immediately if you are:

- intoxicated
- violent
- quarrelsom
 disorderly
- smoking in a smoke-free area
- using or in possession of prohibited drugs

If you are refused entry or asked to leave for being intoxicated, violent, quarrelsome or disorderly, you must:

- leave the vicinity of the premises
- (more than 50 metr • not re-enter or
- attempt to re-enter the premises within 24 hours • not re-enter the vicinity
- of the premises for six hours

If you don't comply you're committing a crime.



UNDER 25?

Be prepared to show ID to prove you are at least 18 on entry or when buying alcohol





Drink Spiking & Sexual Touching

Going to parties, pubs or clubs? Be alert and watch your drinks. Don't leave them unattended or you may become a victim of drink spiking.



Drink spiking is when someone deliberately adds alcohol or another drug to your drink without your knowledge and it is illegal in all Australian states and territories. When you're out at a pub, club or party protect yourself:


- many people have their drinks spiked by someone they know: to avoid this, buy or pour your own drinks
- · keep an eye on your friends and their drinks

Drink spiking is serious: In an emergency, telephone triple zero (000) or the nearest police station. For information about sexual assault, or for counselling or referral, call 180




What are the signs?

- Unconscious/blac kouts
- Nausea/vomiting
- Short-term memory loss
- Confusion/disorie ntation
- Hallucinations
- Altered perception of time
- Loss of feeling

How to help someone:

Stay with them and keep talking to them Tell a staff member or security Call an ambulance 000 Report the incident to police



Safety in the Street


- Avoid walking alone at night. If alone, walk in well-lit areas where there are lots of people or catch public transport/taxi.
- Be aware of your surroundings Be alert and aware of what's going on around you. Street names? Landmarks?
- Don't use shortcuts or back lanes.



Isolated areas can be a risk.

Protect your Belongings

- Don't carry large amounts of money
 - Never carry more cash than you need.
- Protect your bag
 - Make sure it is zipped up and not easily accessible.
 - Do not put your bag on the floor or hang it over a chair.
 - Avoid bags dangling by your side.
- Don't carry important documents or valuables with you.
 - Leave your valuables & passports in a safe place.
- Do not leave your valuables unattended or in an unattended vehicle
 - o Don't leave you phone or laptop sitting around



Weapons

- In Australia, individuals <u>cannot carry</u> any weapons of any kind for self-defence. If someone is caught carrying any of the below items, police will <u>arrest</u> and <u>charge</u> them.
- Section 11(3) of the Weapons Prohibition Act 1998 (NSW) states that "The possession or use of a prohibited weapon for personal protection, or for the protection of any other person, is not a genuine reason for the possession or use of the weapon."





Safety Tips for Pedestrians

- Always use pedestrian crossings, it's the safest way to cross the road.
- Check for turning vehicles before you leave the kerb, and while you are crossing the road
- At traffic lights, you must wait for the lights to turn green, regardless of the conditions.

Failing to adhere to this road rule could result in a fine between \$75-\$220.







Cyclist Safety

No bicycle helmet?...



= a \$352 fine!







Cyclist Safety (cont.)

An Australian Standard (AS/NZ 2063:2008) helmet must be worn. The following are not considered bicycle helmets...



- Always lock the wheels and frame to a secure object.
- Always park your bicycle in a well-lit and populated area.
- Always record the serial number, brand and model of your bicycle. Take a photo & keep the receipt.
- Never leave your bicycle unattended and unsecured!







Some electric motorised bicycles known as 'e-bikes' are LEGAL to ride in public in NSW if they comply with certain CONDITIONS.



There are only two types of permitted e-bikes:

- Power-assisted pedal cycles
- Electric power-assisted cycles

BUT they must be designed to be propelled primarily by the rider. They cannot be propelled exclusively by the motor and cannot exceed 25km/h.

Bicycles powered by electric motors are intended only to assist when riding uphill or into a headwind, NOT to be the primary source of propulsion.

Electric powered bicycles which don't comply with these conditions cannot be ridden on roads, or road related areas (such as footpaths shared paths and cycleways) in NSW, except on private land.

Anyone caught riding an illegal electric powered bicycle on a road or road-related area in NSW can face fines starting from \$704.

Beach Safety



If you're caught in a rip current, stay calm, conserve your energy and consider these options:



a.





Swim parallel to the beach or towards the breaking waves. You may escape the rip current.

Reassess the situation If what you're doing isn't working, try one of the other options until you return to shore or you're rescued.

Visit **beachsafe.org.au** or download the app to find out what you don't know about rips.



If you are in the water, be mindful of rip currents. Don't swim against the rip, swim to the side until you can break free from the rip current.
